**Revisions to Fall 2020 Academic Calendar**

In light of the COVID-19 pandemic, the Fall 2020 academic calendar has been changed as shown on the following pages. Regular semester classes will start on the originally scheduled day (August 17), but the semester will be compressed so that all exams will occur before Thanksgiving. On Wednesday November 25, students will leave campus and will not return until after Christmas.

Because of the compressed calendar, we **will** have classes on Labor Day and Yom Kippur. We will also have classes on six Fridays. Each of those Fridays will be designated a different day of the week. For example, Friday, August 28 is designated for Monday classes. Classes that normally meet on Monday will meet on that day. So, a class that meets on Monday and Wednesday will meet on three Fridays during the semester. A class that meets on Tuesday and Thursday will also meet on three (different) Fridays. The Friday class schedule is on the calendar so that you can plan now. **Please note the Fridays that apply to you as you plan for Fall.**

There will also be a revised examination schedule, which will be published at a later date.
